The Urban Land Conservancy is requesting proposals for facilities services for its portfolio of commercial properties that serve local nonprofit organizations in the Denver Metro Area. It also includes vacant land or commercial property owned by ULC. Services are projected to be contracted for the period beginning January 1, 2017 through December 31, 2017.

- All responding companies must provide proof of current General Liability and Workmen's Compensation insurance. Fidelity Bond preferred.
- All responding companies must agree to abide by ULC's Drug-Free Workplace and Non-Harassment policies.
- Most work will be performed Monday Friday during normal office hours. Some after-hours and weekend work, and on-call required to address emergencies.
- Work also includes maintaining areas around outside of buildings, including regular inspection of vacant land held by ULC and litter removal. Mowing is not included.
- Work includes scheduled routine maintenance as well as maintenance work orders, as requested by the Facilities Manager.
- HVAC, electrical, plumbing, and carpentry experience is a plus.
- Must have own tools.
- Reliability (and reliable transportation) is a must.
