Impact East Colfax

Impact East Colfax is a collaboration between ULC and The Fax to build equitable, affordable commercial and residential developments on the East Colfax corridor. ULC and The Fax Partnership embarked upon a community outreach/visioning process through the creation of the Impact East Colfax (IEC) initiative. The Impact East Colfax collaboration includes IEC Aurora Steering Committee members, IEC Denver Steering Committee members, and the IEC project team: Urban Land Conservancy and The Fax Partnership. The IEC Steering Committee members were selected through an outreach and volunteer process led by Urban Land Conservancy and The Fax Partnership launched in 2020. The IEC Steering Committee includes representation from residents, business owners, and development/urban planning professionals with connections to the East Colfax corridor. The IEC process strived to be inclusive by supporting authentic and empowered participation and including and accommodating people who have historically been excluded. The IEC community engagement work has been supported by a grant from The Colorado Health Foundation.

Property and Development Opportunity Overview

Property Background

ULC bought 10660 East Colfax in October 2021. The property is 1.77 acres with 25,000 sq ft of a 1 to 3-story building with front and rear parking lots. A portion of this property is designated for the housing development opportunity as described below. The office building is a mid-century modern structure with iconic golf tee portico columns that ULC converted to a nonprofit center under the name ColfaxLab For Social Good.



Project Program

The IEC Steering Committee's vision is to maintain and enhance cultural diversity and opportunity, resist and repair displacement, and continue to energize the East Colfax corridor through development that can address the community's need for housing and revitalize sites that have been under-utilized. There is currently a request for proposal out to housing developers that demonstrate anti-displacement strategies addressing historical and current physical displacement, resident displacement, and cultural displacement.

Submission Requirements:


